Appointments

Peace Officer Mental Health Grant was presented by Reyna Martinez-Ramirez. This project was started in 2021 with three agencies in Alamosa and quickly expanded to neighboring law enforcement agencies. From there, it grew to 11. At the end of the grant, 103 officers were served for mental health therapy, counseling, and consultations in 2023. The grant was in regards to expanding the project and allowing

RETAC to include jail deputies that are not post certified, first responders, and dispatchers. In critical incidents, everyone is affected, not just one agency. The San Luis Valley really comes together and unites as one, and that's a big motto for RETAC, one mission, one team. They come together and help each other out in their most needed times.

In 2023, they started with 103 officers and are now serving 175. With that they are also able to serve immediate families because it doesn't only affect first responders, it affects families as well. They will be able to provide counseling to their children and family. And they are starting a peer support group.

In 2023 there were 12 critical incidents that needed debriefing, and additional support on top of those. The critical incidents are from officer involved shootings, child fatalities, fires, and school shootings. RETAC is requesting additional funding for the police officer mental health grants, they might apply for another \$200,000. And they may reach out to neighboring agencies in Walsenburg, Trinidad, or Salida. The grant application is due January 19.

Roni Wisdom said that Alamosa County has a partnership with RETAC that allows for Reyna Martinez-Ramirez to apply for the grants and Alamosa County to act as a pass through. These grants are very important and make a big difference. The Commissioners have a meeting on January 17th, so if they could review the grant application at that time, it could address any final concerns that the Commissioners may have.

Public Hearing for Supplemental Budget Resolution Appropriating Additional Funds for Alamosa County - Maricruz Mora, Alamosa County Controller, presented Resolution 2023 F-5.

WHEREAS, on the 7th day of December, 2022 the Board of County Commissioners adopted its 2023 calendar year budget; and

WHEREAS, Alamosa County has:

- a) to account for increased capital outlay expenditures for the project completion of the Lane 6 North in the Road & Bridge fund
- b) to show increased expenses in the Capital Projects Fund c) to show increased expenses in the Debt Service fund
- d) to show increased expenses in the Justice Center Fund
- e) to show increased expenses

in the Internal Services fund

WHEREAS, Alamosa County has received unanticipated revenue or revenues not assured at the time of adoption of the budget, or will utilize available undesignated fund balances as hereinafter set forth.

NOW THEREFORE BE IT RESOLVED, by the Board of County Commissioners,

Alamosa County, Colorado as follows:

Section 1. That the FY2023 appropriation for the

- a) Road & Bridge Fund is increased by \$10,995,000.00 from \$3,689,393.00 to \$14,684,393.00.
- b) Capital Projects fund is increased by \$60,000.00 from \$20,000.00 to \$80,000.00
- c) Debt Service fund is increased by \$36,000 from \$1,863,000 to \$1,899,000
- d) Justice Center fund is increased by \$95,000 from \$5,326,995 to \$5,421,995
- e) Internal Services fund is increased by \$24,000 from \$129,000 to \$153,000.

BE IT FURTHER RESOLVED that a certified copy of this resolution be filed with the Division of Local Government and the Department of Local Affairs by the Clerk of the Board.
